They provide us with the scale to establish our global battery business. Agratas will be driven by our pursuit of green growth and technological progress.

Tata Agratas designs and makes batteries for the automobile and energy sectors (representational image) Tata Group is considering a potential spinoff of its battery business, according to people familiar with the matter, as the Indian conglomerate expands its foray in the country's renewable-energy and



electric-vehicle sectors.

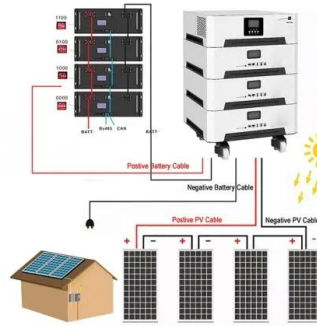

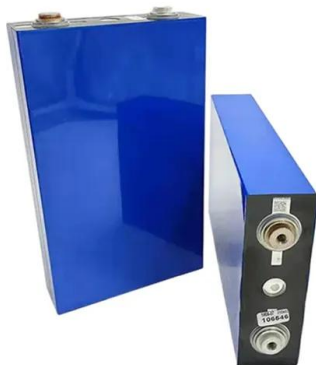

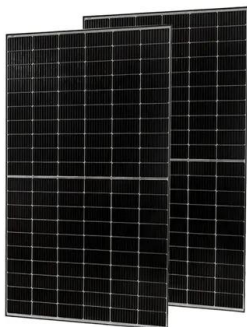
