You may bring spare lithium batteries for devices such as laptops, cell phones and cameras, in carry-on baggage only. This also includes external battery chargers.

Batteries

Due to the possibility of a fire, all batteries for electronic devices should be packed in the original retail package and wrapped in insulating tape to prevent loose batteries from coming into contact with metal objects. Please note: Lithium batteries should be packed in carry-on bags, not checked bags, to protect the battery from getting crushed or punctured during the flight.



Lithium batteries with more than 100 watt hours

With airline approval, passengers may also carry up to two spare larger lithium ion batteries (101-160 Wh) or lithium metal batteries (2-8 grams). This size covers the larger after-market extended-life laptop computer batteries and some larger batteries used in professional audio/visual equipment.

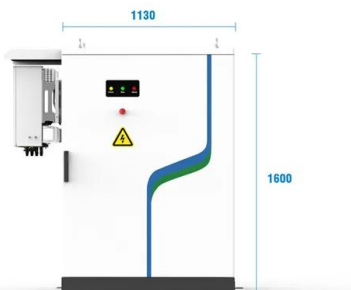

Batteries

Each battery must hold no more than 160 watt-hours. Any lithium ion battery capable of more than 160 watt-hours is prohibited on all passenger aircraft. A lithium ion battery installed in a personal electronic device can be transported as checked or carry-on
