

# **Alberta indexed renewable energy credit**





## Overview

---

On June 10, 2019 the Government of Alberta advised the AESO that they will not be continuing with the Renewable Electricity Program (REP) and thus do not intend to proceed with additional competition rounds. The government provided direction moving forward that the AESO should continue to oversee the projects.

In January 2016 the Government of Alberta directed the AESO to develop and implement a program to bring on new renewable generation capacity. Through the Renewable Electricity.

Each competition for the REP may include up to three stages and is anticipated to run for approximately 7-11 months. The stages include a Request for Expressions of Interest (REOI), a Request for Qualifications (RFQ) and a Request for Proposals (RFP). All.

RECs were created as a means to track progress towards and compliance with states' Renewable Portfolio Standards (RPS), meant to support a cleaner generation mix.

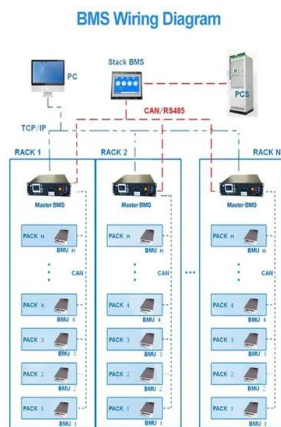
