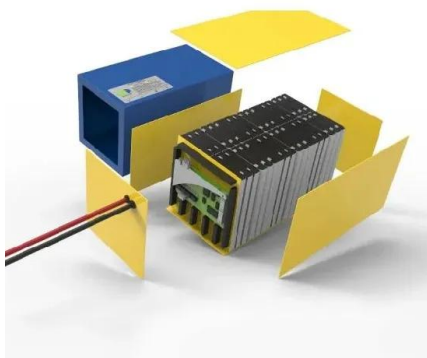
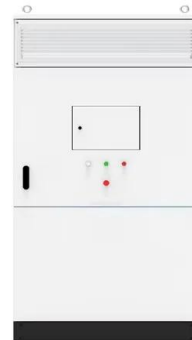

### Iowa Net Metering

Net Metering, often referred to as NEM, is what allows homeowners in Iowa with solar panels to receive a credit for any excess energy produced compared to what your home actually consumes. When you go solar, your utility provider will come out and install a second meter alongside your normal electric meter.

Note: Iowa S.F. 583, enacted on March 12, 2020, makes substantial changes to net metering rules, which will go into effect by July 1, 2027 or when statewide distributed generation penetration reaches 5%, ...
