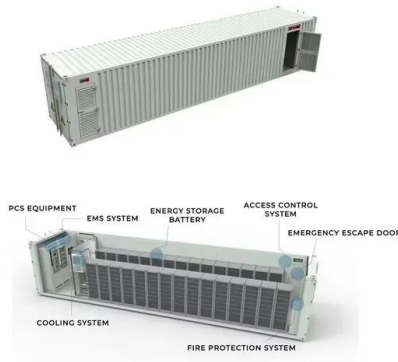

A long history of clean energy celebrated at Bagnell Dam

In 2018, hydropower was the largest generator of clean, renewable electricity nationwide, representing 7% of total U.S. electricity generation and 39.5% of renewable electricity



generation. The U.S. hydropower fleet is comprised of approximately 2,200 generating facilities with a total capacity of roughly 102 gigawatts (GW), which includes 95% of U.S. storage ...
