When asked to describe in their own words the biggest problem with the political system in the U.S. today, Americans point to a wide.

Far fewer adults name a specific strength of the political system today when asked to describe the system's biggest strength in their own words. More than half either say that the system lacks a.

The public remains roughly evenly split over whether there are clear solutions to the biggest issues facing the country. Half of Americans today say.

What do Americans think about the political system today?

More than eight-in-ten adults say that each of the following is at least a somewhat good description of the U.S. political system today: Special interest groups and lobbyists have too much say in what happens in politics (84%). About six-in-ten (63%) think ordinary Americans want to make the political system work well.

And trust in the federal government, which has been low for nearly two decades, hovers near record lows. Only 4% of Americans now say the political system is working extremely or very well, with nearly three-quarters saying it isn't. A majority (63%) say they have little or no confidence in the future of the U.S. political system.

Do ordinary Americans care about making the political system work well?



Partisan fighting, the high cost of political campaigns, and the outsized influence of special interests and lobbyists are each seen as characteristic of the U.S. political system by at least 84% of Americans. Yet 63% also say that “ordinary Americans care about making the political system work well” is a good description of U.S. politics today.

What do Americans think about the future of politics?

A majority (63%) say they have little or no confidence in the future of the U.S. political system. Views of Congress, the Supreme Court and the political parties also remain deeply – and in some cases, historically – negative. Meanwhile, there are wide partisan differences in views of several aspects of federal-state relations.

What problems are undermining the American political system?

Through an examination of its time-series data, Freedom House identified three enduring problems that play an outsized role in undermining the health of the American political system: unequal treatment for people of color, the improper influence of money in politics, and partisan polarization and extremism.

1. Democracy and government, the U.S. political system, elected

In 2014, about four-in-ten members of both parties gave the political system a positive rating (37% of Republicans, 36% of Democrats); in 2009, identical shares of Republicans and Democrats (52% each) said the U.S. political system was at least above average.

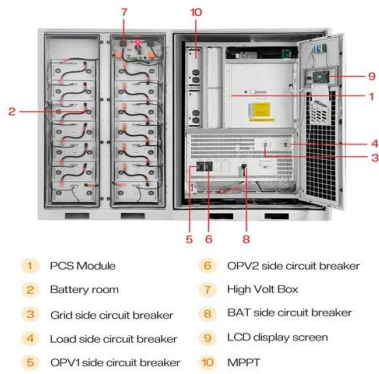

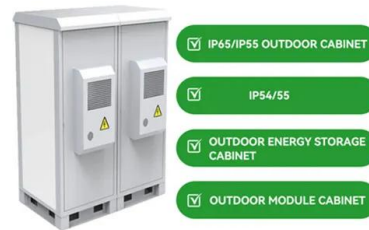
