

Are solar panels legal in florida





Overview

You have an absolute right to install solar and other energy-saving structures on your property. Florida law prohibits organizations like HOAs and other local governance from banning or otherwise interfering in a homeowner's right to solar installation. Are solar panels legal in Florida?

Florida law forbids ordinances, deed restrictions, covenants, or similar binding agreements from prohibiting solar equipment use.

Do you need a permit to install solar panels in Florida?

The inspection must be completed before the system is connected to the grid, and any necessary repairs or adjustments must be made before the system can be turned on. Another important aspect of Florida's solar laws is the process of obtaining a permit to install a solar panel system.

Yes, solar panels can add to your home value in Florida and Floridians don't pay property tax on the value added by solar and/or battery storage. According to a study by Zillow, homes with solar panels sold for 4.1% more on average than comparable homes without solar in 2019.
