State income tax credit: Homeowners in Arizona may claim the state's Residential Solar and Wind Energy Systems Tax Credit on their taxes. This credit lets you claim 25% of the cost of solar



### Arizona Solar Incentives, Tax Credits & Rebates (2024 Guide)

As with the state tax credit, you don't qualify for the ITC if you lease your solar power system or are in a power purchase agreement. The ITC will reduce to 26% in 2033 and drop to 22% in 2034. It's set to end in 2035 unless Congress renews it.

Arizona law provides a solar energy credit for an individual who installs a solar energy device in his or her residence located in Arizona. The solar energy credit for buying and installing a solar energy device is 25% (.25) of the cost, including installation, or \$1,000

Did you install solar panels on your house? A nonrefundable individual tax credit for an individual who installs a solar energy device in taxpayer's residence located in Arizona.



### Arizona Solar Incentives & Rebates

Similar to the residential solar energy credit, Arizona offers a state tax credit for solar energy systems installed on commercial properties. The credit is equal to 10% of the cost of the solar energy system, up to \$25,000 per installation.



### **Arizona Solar Incentives, Tax Credits, & Rebates**

Residential Solar and Wind Energy Systems Tax Credit - Individual taxpayers who install a solar or wind energy device at their Arizona home are eligible for Arizona's solar energy credit. No matter how many energy devices are placed, a credit of up to \$1,000 is provided against the taxpayer's income tax for 25% of the cost of a solar or wind energy device.

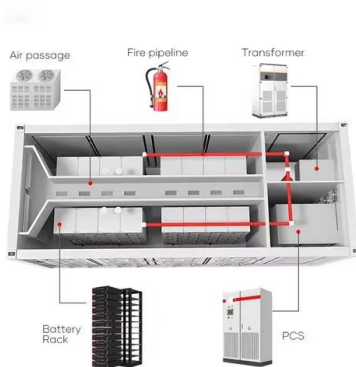

## Residential Solar and Wind Energy Systems Tax Credit

Arizona's Solar Energy Credit is available to individual taxpayers who install a solar or wind energy device at the taxpayer's Arizona residence. The credit is allowed against the taxpayer's personal income tax in the amount of 25% of the cost of a solar or wind energy device, with a \$1,000 maximum allowable limit, regardless of the number of energy devices installed.



## Unlock Arizona Residential Solar Incentives , Save More

Through the Inflation Reduction Act signed into law on August 16, 2022, the 30% solar tax credit that ended in 2021 was reinstated for all residential solar installations through 2033. This higher 30% rate is also retroactive to 2022 solar installations previously subject to the 26% rate.
