Post-Rebate cost = \$17,500 You'd then apply the 26% solar tax credit to find your net purchase price (rebates are always factored in first). So \$17,500 times 26% equals \$4,550. Subtracting this amount from the post-rebate cost we get \$12,950. Net Purchase

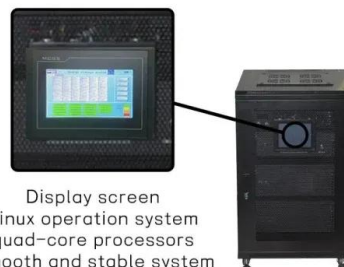
