Can solar panels be profitable?

Installing solar panels and signing up to an SEG tariff is unlikely to be anywhere near as profitable as FIT rates were just a few years ago for two reasons: All energy suppliers with more than 150,000 customers are required to offer a Smart Export Guarantee tariff and a couple have voluntarily decided to offer them.

What is the best solar energy export tariff?

The best overall export tariff is Intelligent Octopus Flux. With this tariff, customers who choose Octopus as their energy supplier can typically gain 29.4p for every kWh (kilowatt-hour) of solar electricity they export between 4pm and 7pm, and 22.1p per kWh at all other times.

Can I switch energy suppliers with solar panels?

The company paying your subsidy is known as your FIT/SEG licensee – but they don't need to also be your energy supplier. You can actually have separate contracts for your energy supply and your export payments. Switching energy suppliers with solar panels doesn't need to affect your export tariff contract at all.

Can you buy solar panels if you can't afford solar?

If you can choose your energy provider, you might be able to choose one selling renewable power. If you want to power your home with renewable energy but can't afford rooftop solar panels, you might feel a bit stuck.

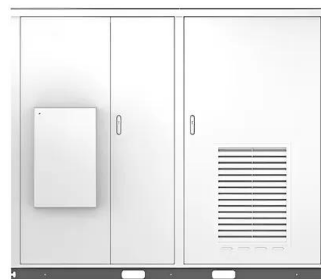

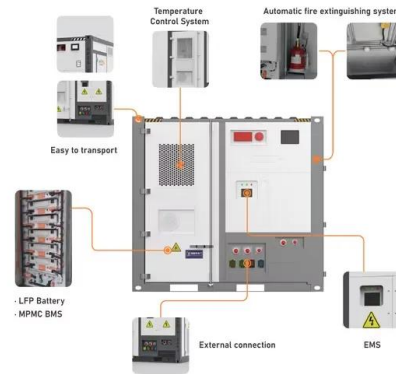

How does switching energy supplier affect my Feed-In tariff?

First off, you can still switch gas and electricity suppliers when you have solar panels or generate your own renewable energy in another way -- but you must switch to an eligible supplier.
