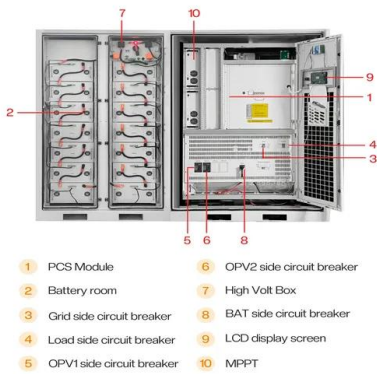
### Sustainability Case Study: Renewable Energy , Brookfield
