You can make a report as a guest, without registering and creating an account. But we recommend you create an account first, because then you'll be able to: 1. save and come back to a report you haven't finished 2. see.

You can report scams, fraud and online crime (cybercrime) to Action Fraud, except you should report: 1. business or personal tax fraud to HMRCExternal Link(His Majesty's Revenue and.

To be able to get an update on your report, you need to register with Action Fraud before you make your report. Then you can track the progress of your report by logging into your.

After you've reported something to Action Fraud, your report will be sent to the National Fraud Intelligence Bureau (NFIB), which is part of the City of London police. They'll decide what to do next. If the NFIB decide there might be.

If the police decide not to investigate your case as a crime, you might still be able to get compensation or money back by bringing a civil case.

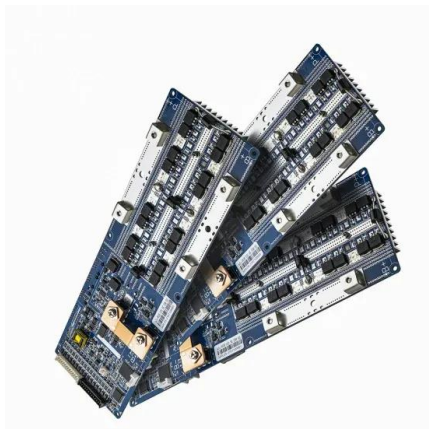

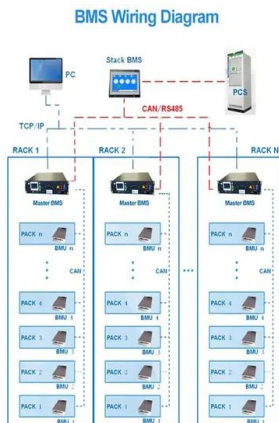

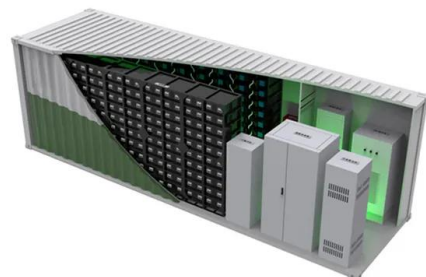
