

Can I exchange photovoltaic panels for money after using them up





Overview

You need to have a renewable electricity generating system that meets the SEG eligibility requirements. You must have a meter capable of providing half-hourly export readings. This would typically be a smart meter. Speak to your energy supplier about getting a smart meter installed if you do not already have one.

You need to apply directly to a SEG tariff supplier to get paid. The OFGEM website lists the energy suppliers that provide SEG tariffs. Your SEGtariff supplier does not need to be the same as.

Use the Energy Saving Trust calculator to estimate: 1. how much you could save from solar panels or other renewable electricity generating systems 2. how much you could earn.

Why do energy suppliers buy solar panels?

How do free solar panel schemes work?

'Free' solar panel schemes, also known as rent-a-roof schemes, used to be commonplace a few years ago. These were run by companies eager to cash in on the feed-in tariff (FIT). This guarantees payment in return for electricity generated using renewable technologies, including solar power.

What happens if a solar PV company goes out of business?

Sometimes solar PV companies sell on installations, or the ownership changes if a company goes out of business. If you're unsure who owns the solar panels on your home, you can contact energy regulator Ofgem's Feed-In Tariff Register Team at fitregister@ofgem.gov.uk.



Do solar panels save money?

Installing solar panels and signing up to a SEG tariff should help you save money in the long term. You can benefit in two ways: The biggest saving comes from buying less electricity from your energy supplier. Every unit (kWh) of self-generated power is one less unit of energy you have to buy from a supplier.

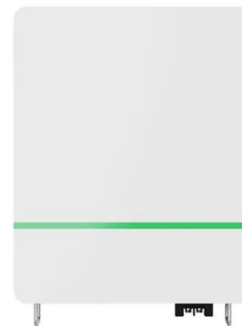
