Who is PT CG Power Systems Indonesia?

1. GENERAL PT CG Power Systems Indonesia, (the “Company”), was established under the name of PT Pauwels Trafo Asia within the framework of the Foreign Investment Law No. 1 of 1967 as amended by law No. 11 of 1970 based on Notarial Deed No. 47 of Irawati Marzuki Arifin, S.H., dated November 20, 1990.

Who owns CG Power Systems Indonesia?

CG Power Systems Indonesia, a subsidiary of CG Power Systems Belgium NV, manufactures power transformers in the region. This acquisition represents Elsewedy’s first major investment in Southeast Asia. Hiswara Bunjamin & Tandjung advised Elsewedy Transformers Indonesia Holding Ltd on the deal.

How CG Power & Industrial Solutions Ltd secured banking facilities?

These facilities are secured by Corporate Guarantee from CG Power and Industrial Solutions Ltd. The Company obtained banking facilities from UOB based on banking facilities agreement dated May 21, 2015, with combined limit of US\$10,000,000 (equivalent to Rp142,450,000).

How long is CG Power & Industrial Solutions' facilities period valid?

The facilities period is valid until December 17, 2019. These facilities are secured by Corporate Letter of Comfort from CG Power and Industrial Solutions Ltd. and the Company’s land, factory, machineries, inventories and receivables. The Company was in compliance with all of the loan covenants for those bank facilities.

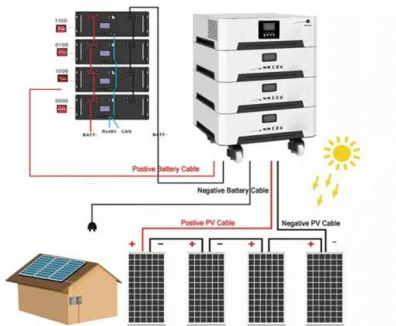

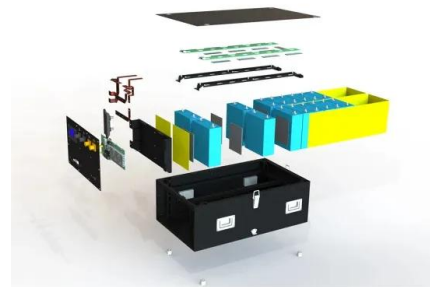
