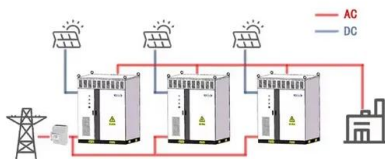

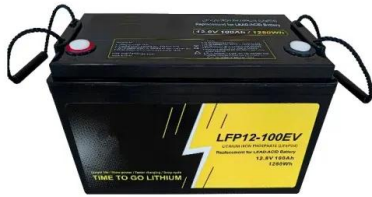

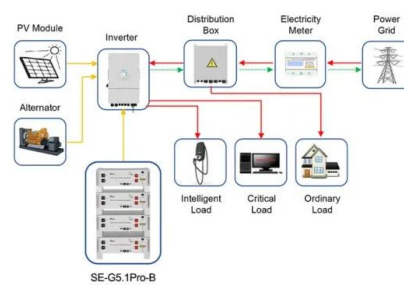

Application scenarios of energy storage battery products

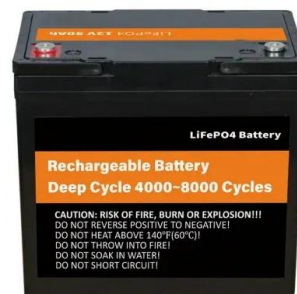

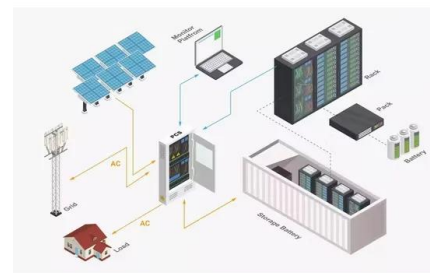

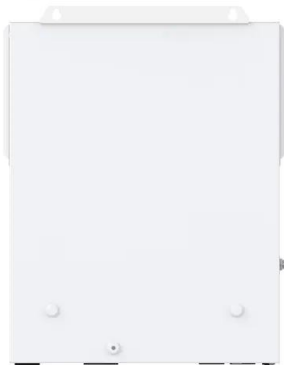
### First Solar signs 167 MWp wind and solar energy PPA with Cleantech
