What is energy storage solutions?

Energy Storage Solutions will help create a more reliable, resilient Connecticut, especially for vulnerable communities and those hit hardest by storm-related outages. But backup power does more than just help during an outage! The battery systems installed through this program will provide additional benefits to all customers.

Who owns C&I energy storage systems in Connecticut?

It is administered by the Connecticut Green Bank, and the utilities Eversource and UI. ESS has so far approved 46.4 MW/139.4 MWh of C&I energy storage systems. The C&I tranche 1 includes 27 projects submitted by six developers at locations such as water treatment plants, manufacturing facilities, public schools and health clubs.

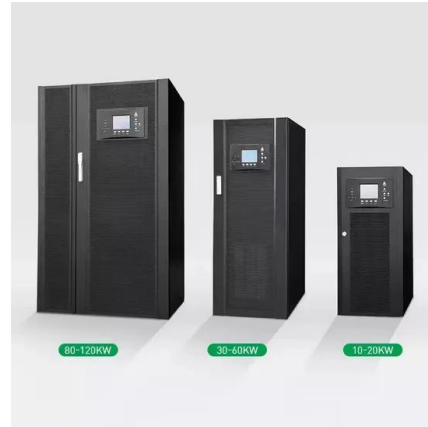

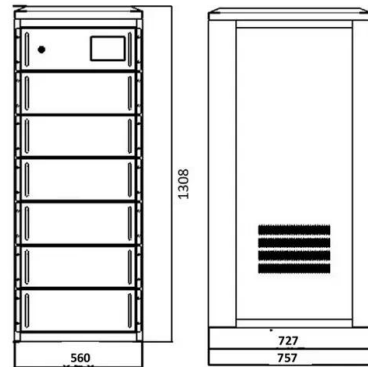

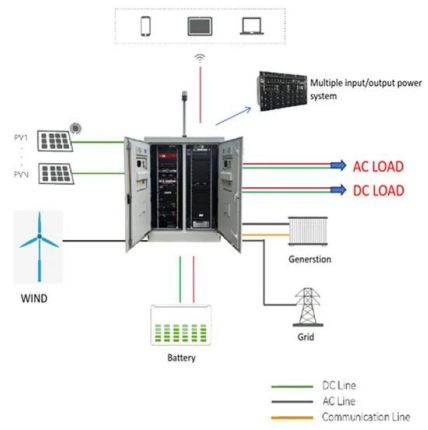
