Overview

Is China revoking antidumping duty on crystalline silicon photovoltaic cells?

The Department of Commerce (Commerce) is revoking, in part, the antidumping duty (AD) and countervailing duty (CVD) orders on crystalline silicon photovoltaic cells, whether or not assembled into modules (solar cells), from the People's Republic of China (China) with respect to certain off-grid.

Can crystalline silicon photovoltaic cells be imported?

The U.S. Department of Commerce (Commerce) preliminarily determines that, except as noted below, imports of certain crystalline silicon photovoltaic cells, whether or not assembled into modules (solar cells and modules), that were exported from the Kingdom of Cambodia (Cambodia), Malaysia, the.

Which crystalline silicon photovoltaic cells are excluded from the Order?

Also excluded from the scope of the Orders are crystalline silicon photovoltaic cells, not exceeding 10,000 mm² in surface area, that are permanently integrated into a consumer good whose function is other than power generation and that consumes the electricity generated by the integrated crystalline silicon photovoltaic cell.

What products are covered by crystalline silicon photovoltaic cells?

The products covered by these investigations are crystalline silicon photovoltaic cells, and modules, laminates, and panels, consisting of crystalline silicon photovoltaic cells, whether or not partially or fully assembled into other products, including, but not limited to, modules, laminates, panels and building integrated materials.

When will antidumping duty deposits be collected for Wuxi Suntech?

Antidumping duty deposits applied to Wuxi Suntech will be collected as of the date of publication of Commerce's preliminary AD determination. In order for this early duty deposit collection to be maintained, the U.S. International



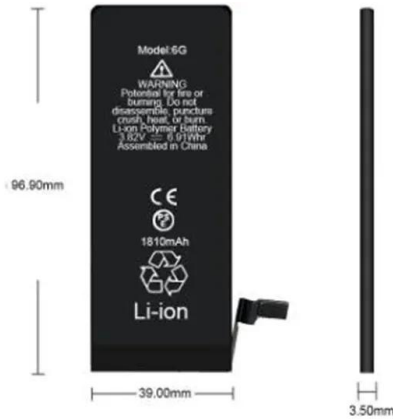
Trade Commission (ITC) must also reach an affirmative finding regarding critical circumstances.

Are governments providing countervailable subsidies for CSPV cells?

The CVD petition alleges that the Governments of the targeted countries are providing countervailable subsidies with respect to the manufacture, production, and export of CSPV cells. Petitioners allege that the domestic industry has been materially injured and is threatened with further material injury by the subject imports. 1.
