Universal wastes are still a hazardous waste. Universal waste management standards for PV modules apply only in California. If the waste is shipped to another state from California, a hazardous waste determination must be made (CCR 66262.11) to determine if the waste is a RCRA hazardous waste.

### EPA Announces Plan to Modify and Expand the RCRA Universal ...

EPA recently announced that it is developing a proposed rule that would (a) modify the existing "universal waste" requirements under RCRA for lithium batteries and (b) expand the universal waste rule to cover waste photovoltaic solar panels. The Agency has indicated that the proposal might be ready for publication by the summer of 2025.



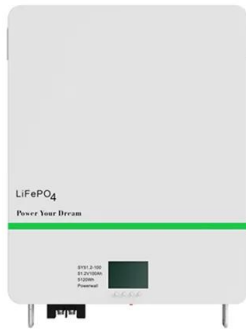
### EPA Announced Plans to Propose New Universal Waste ...

EPA is developing a proposed rule to add solar panels to the universal waste regulations and to add tailored universal waste standards for lithium batteries. EPA is working on this rulemaking in part in response to a petition submitted by a broad coalition of industry associations to regulate solar panels as universal waste.



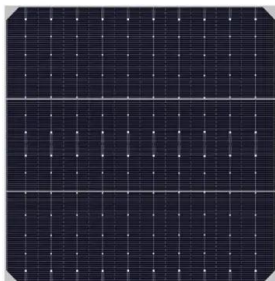

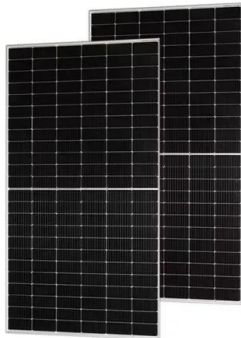
