

Florida solar power program





Overview

Most Florida residents are eligible to receive the Federal Solar Tax Credit—also known as the Residential Clean Energy Credit. This allows eligible homeowners to deduct up to 30% of their solar panel installation cost from their federal income taxes. Many Florida homeowners also pair battery storage with their solar panel system. Does Florida offer solar incentives?

The state encourages its residents to install solar panels, although it doesn't rank in CNET's list of seven best states for solar incentives. Florida is one of only three states that offer property-assessed clean energy loans for solar.

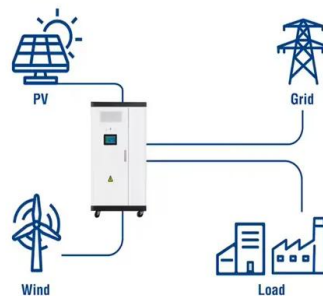
