What is the Solar for all grant competition?

On April 22, as the Biden-Harris Administration celebrates Earth Day, the U.S. Environmental Protection Agency announced 60 selectees that will receive \$7 billion in grant awards through the Solar for All grant competition to deliver residential solar projects to over 900,000 households nationwide.

How much will solar energy save a community?

This \$7 billion investment will generate over \$350 million in annual savings on electric bills for overburdened households. The program will reduce 30 million metric tons of carbon dioxide equivalent emissions cumulatively, from over four gigawatts of solar energy capacity unlocked for low-income communities



over five years.

What does Doe's advancing US thin-film solar photovoltaics funding program entail?

Of the eight projects DOE selected for the Advancing U.S. Thin-Film Solar Photovoltaics funding program, four will address opportunities to improve efficiency, reduce costs, and bolster the supply chain for CdTe systems. DOE's Solar Photovoltaics Supply Chain Review identified CdTe as an opportunity to expand domestic production of solar panels.

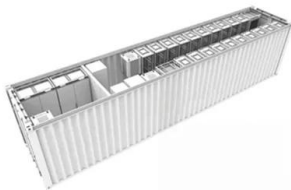

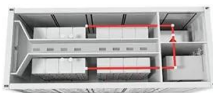

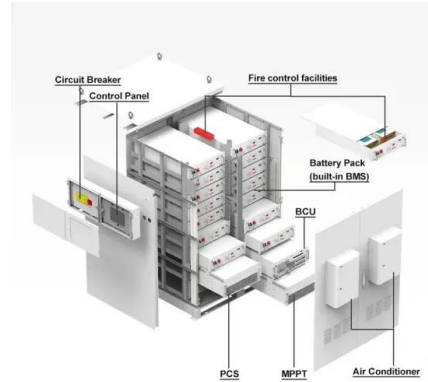

Government rebates and loans for solar

Example interest-free loan payment plan You take an interest-free loan for \$6,800 for a home rooftop solar system. You are repaying the loan over 4 years in monthly instalments. This works out to 48 instalments. $\$6,800 \div 48 = \141.67 Your monthly repayment

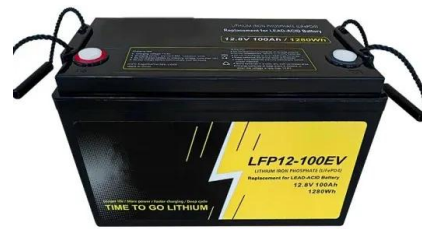
