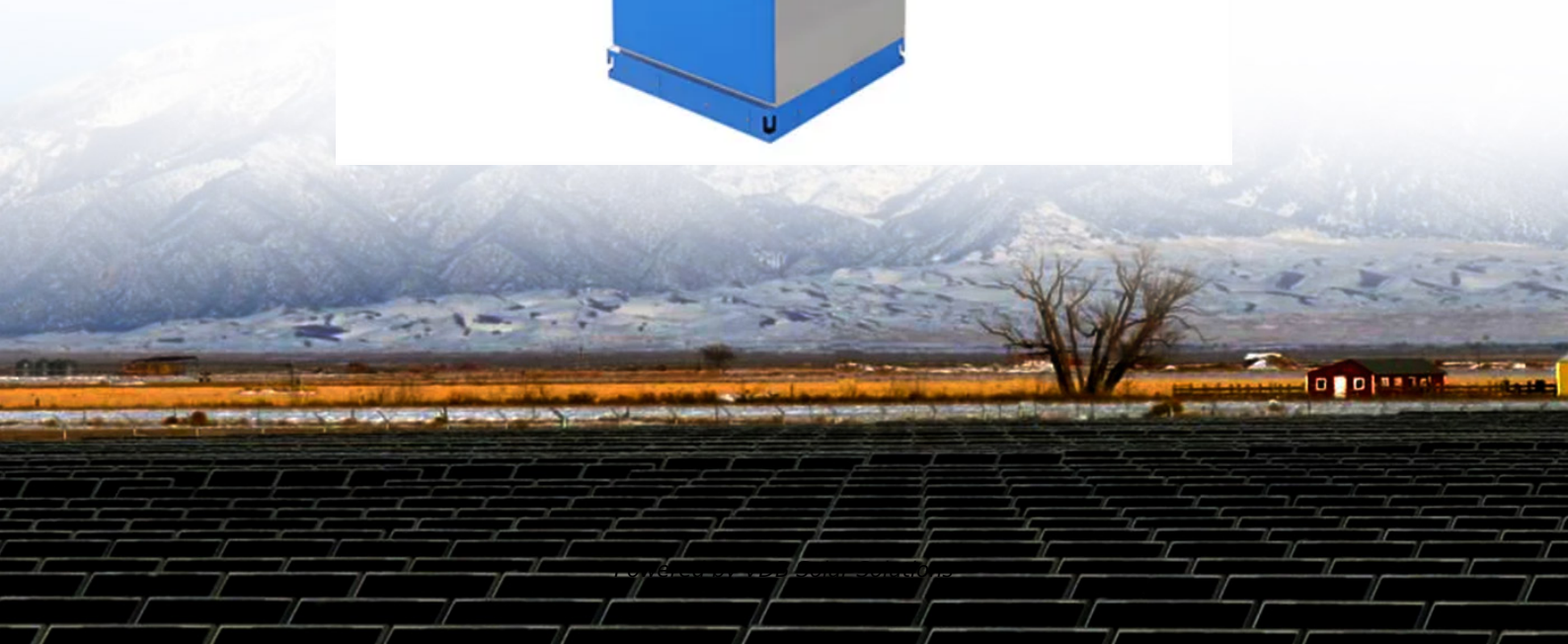

Overview

What is a Public Procurement Code in France?

1. Overview In France, the procurement of government contracts is primarily governed by the Public Procurement Code (code de la commande publique or CCP). The CCP brings together the rules governing the awarding and performance of public contracts and concessions in a single text. They were previously issued in different texts until 1 April 2019.

What is the Supplier Portal?

The Supplier Portal is an electronic tendering system used to publish tenders and relevant documentation and to receive submitted bids for ongoing procurements. Current and forthcoming business opportunities at ESS are posted in the Procurement Listings. Completed tenders are published quarterly in the Contract Award Notices.
