Overview

HONOLULU - Hawaiian Airlines today announced it will no longer accept smart bags containing non-removable lithium ion batteries as checked or carry-on luggage beginning Jan. 15. These batteries have been known to short-circuit, posing a safety risk for airlines. Can I bring a lithium battery on a plane?

You may bring spare lithium batteries for devices such as laptops, cell phones and cameras, in carry-on baggage only. This also includes external battery chargers (portable rechargers) containing a lithium-ion battery. Guests are limited to no more than two (2) spares per person, not to exceed 160 watt-hours.

Are lithium-ion batteries a risk to aviation?

There is provision for exceptional updates where an unacceptable risk to aviation has been identified. Due to the high energy density of lithium batteries, usage of lithium-ion batteries is expected to increase elevenfold between 2020 and 2030.

Should lithium batteries be shipped by air?

Regulations for shipping lithium batteries by air are in place to protect everyone who would come in contact with a lithium battery shipment while it is being transported as air cargo; with training being required for everyone in this supply chain, to protect the aircraft, and the people in the aircraft, that is carrying the batteries.

Are lithium batteries rechargeable?

Lithium batteries fall into two broad classifications; lithium metal batteries and lithium-ion batteries. Lithium metal batteries are generally non-rechargeable and contain metallic lithium. Lithium-ion batteries contain lithium which is only present in an ionic form in the electrolyte and are rechargeable.

Restricted items

Batteries - Any spare lithium or lithium ion batteries must be carried on with terminals protected from short circuit. Devices with installed lithium or lithium ion batteries should be carried on as ...

Lithium Battery Guidance Document

1. The employer must identify the different configurations of lithium batteries that they ship, i.e. lithium batteries and/or lithium batteries packed with equipment and/or lithium batteries contained in equipment; lithium metal batteries and/or lithium ion batteries.

Conditions and Charges for Acceptance of Special Items

If the battery cannot be removed HA will only accept a battery that is 100 Wh or less; non-removable lithium-ion batteries over 100 WH are prohibited. Battery terminals must be ...

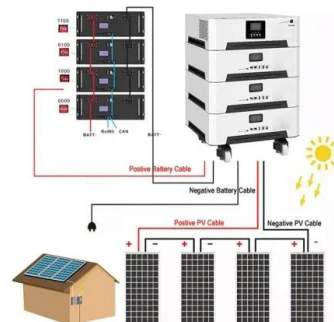

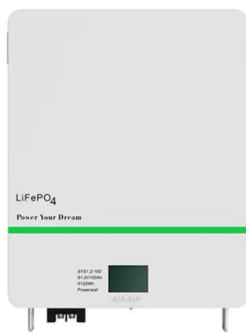
Rule 9: Ticket Validity

Lithium battery operated units. All removable lithium batteries must be removed and carried in the guest compartment of the aircraft as carry-on baggage. NOTE: LITHIUM BATTERIES IN EXCESS OF 300-WATT HOURS (300 WH) ARE COMPLETELY PROHIBITED.

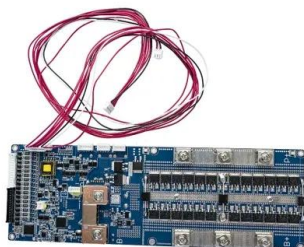


Batteries and Flammable Liquid

Fed Officials Issue Interim Rule Covering Lithium Batteries On Planes

Passengers are allowed to take lithium batteries with more than 100 watt hours in carry-on bags with an airline's approval but are limited to two spare batteries. Federal transportation officials drafted the latest rule following multiple incidents reported since 1991 of lithium cells or batteries on board planes catching fire or smoldering.



Travel with your personal wheelchair or mobility device

If you have a lithium-ion battery-powered mobility device, you may travel with 1 spare battery up to 300watt-hours (wh), OR 2 spare batteries, up to 160watt-hours (wh) each. The spare battery limit applies per device.



International Rule 4: Restricted Items

Electronics including drones that are lithium or lithium-ion battery operated. Lithium or lithium-ion batteries can overheat and cause harm. Electronics that are lithium or lithium-ion battery operated and exceed regulatory limits (are prohibited, other than (i) permitted assistive devices like wheelchairs or (ii) as an exception stated below.

Batteries

Each battery must hold no more than 160 watt-hours. Any lithium ion battery capable of more than 160 watt-hours is prohibited on all passenger aircraft. A lithium ion battery installed in a personal electronic device can be transported as checked or carry-on



Shipping lithium batteries by air

Officially, yes: Lithium-ion batteries are governed under the United Nations regulations UN3480 and UN3481 as Class 9 "miscellaneous dangerous goods." Two dangers stand out: First, improperly packaged lithium-ion batteries can lead to short circuits if they come into contact with each other or with other conductive surfaces.. Second, thermal runaway can ...
