

# **Hoa restrictions on solar panels**

### What to Expect: Your HOA and Solar Panels

Florida Statute 163.04 ensures homeowners can install solar panels with the following restrictions:  
- Solar panels should face south or within 45 degrees of true south. - HOAs can determine the installation site on the roof as long as it doesn't compromise system efficiency.

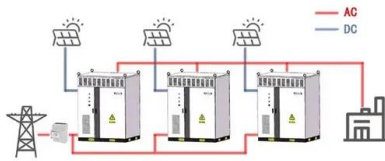


### **HOA Solar Panel Laws in VA, NC, SC, and GA in 2024**

NC Supreme Court Ruling (2022): In June 2022, the NC Supreme Court ruled that while HOA solar panel laws cannot outright ban solar panels, they can dictate their placement. However, they cannot require placement that would render the solar panels ineffective or significantly reduce their productivity.

HOA Restrictions on Solar Panels

When it comes to solar panels, however, you have clear legal guidelines on what restrictions your HOA can place on your solar panel project in Texas. In fact, the law is on your side. According to House Bill 362, which was signed into law in 2011, the law forbids HOAs from prohibiting solar energy installations unless several very specific circumstances occur.

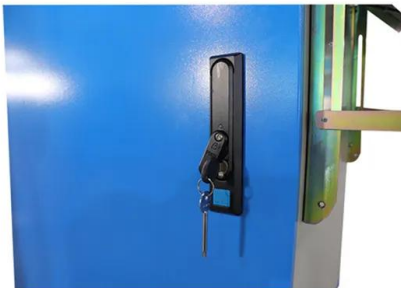

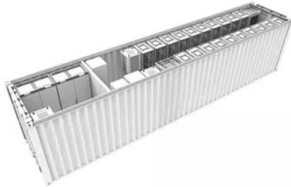

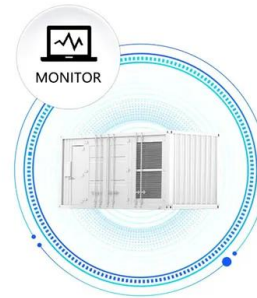
