The Alternative Energy Development Board (AEDB) is a government organization operating under the Ministry of Water and Power in Pakistan. AEDB has been regulating alternative energy development since 2006. AEDB Solar Company Registration is a technical process that requires an AEDB expert Consultant for End to End Solutions.

Who is an investor in a solar project in Pakistan?

*In this Guide the general term “Investor” is used to mean “Contractor” or “Developer”, i.e. persons who intend to implement or who are already implementing a project to construct a solar plant in Pakistan.

Is AEDB registration mandatory for on-grid or net metering solar systems?

Any individual or company cannot install an on-grid or net metering solar system (sale to WAPDA) unless they possess a valid AEDB registration. AEDB registration is mandatory for such installations, as per the new registration policy for the years 2021-2024. AEDB will issue certifications for 3 years instead of 1-year registration.

Does Pakistan need solar power?

Pakistan has tremendous potential to meet its power demand needs from renewable energy sources and, in particular, solar. Solar irradiance levels in parts of Pakistan, particularly in the southwest, are on par with the best in the world with global horizontal irradiance (GHI) values over 1500 kWh/m² in over 90% of the country's land area 2.

Can a business register in AEDB, Pakistan?



Businesses in Pakistan can register with the Alternative Energy Development Board (AEDB) as long as they meet the other requirements and qualifications set by the board. There is no specific age requirement for a business to be registered.

Are there any solar projects in Pakistan based on a bilateral basis?

For direct sales, they are required to pay wheeling charges for the use of the transmission/and or distribution grid network used to transport the power from the plant to the purchaser.
