

How to ship lithium ion batteries to hawaii





Overview

When shipping lithium batteries to Hawaii, you have two main options for transport – ground or air. Ground transport typically involves trucking or freight shipping. This method is generally cheaper, but also slower. Transit times can take 1-2 weeks. Air transport is faster, but comes at a higher cost. Can You ship lithium batteries to Hawaii?

If you've lived in Hawai'i for any length of time, you know that shipping items to the state can present some challenges. Some stores don't ship to Hawai'i, while others tack on exorbitant fees. Still others are willing to ship to Hawai'i—but exclude certain items. What kind of solutions are available for shipping lithium batteries to Hawaii?

Can I ship a lithium battery by Air Service?

Shipping lithium batteries by air service Regulations differ depending upon what type of lithium battery you are shipping (lithium ion or lithium metal) and whether you are shipping batteries packed with equipment or batteries contained in equipment. Reminder: UPS does not accept Section II shipment.

Can I ship a lithium battery cross-border?

There are regulations attached to the cross-border shipping of batteries to ensure they travel safely. These regulations vary depending on the type of batteries. Lithium batteries, for example, are classified as Dangerous Goods, so not all types of lithium batteries are accepted by DHL Express which you can check here.

Do I need a specific lithium battery Shipping Class?

FedEx Ground strongly recommends that anyone shipping lithium batteries take a specific lithium battery shipping class in order to better understand these complex regulations and meet DOT/ICAO/IATA/IMDG/ USPS requirements.



Can You ship a battery across a country?

Many electronic products and devices contain batteries – in particular, lithium batteries, which are commonly found in laptops, smartphones, tablets, medical devices and power tools. There are regulations attached to the cross-border shipping of batteries to ensure they travel safely. These regulations vary depending on the type of batteries.

What is a bill of lading for lithium battery shipments to Hawaii?

For lithium battery shipments to Hawaii, the bill of lading must clearly identify the batteries and quantity, and indicate they are fully regulated Class 9 hazardous materials. The document helps ensure all cargo handlers are aware of the shipment contents and any risks.

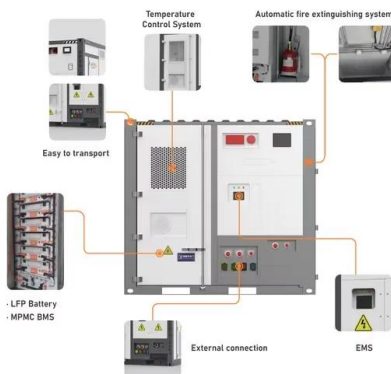

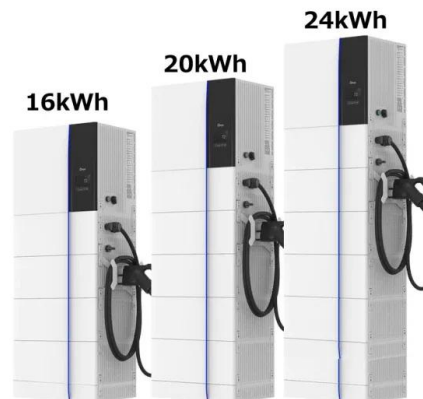

The cost of shipping lithium batteries by USPS will be based on the weight of the package and the destination. From 2021 till now, USPS's cost to ship lithium batteries has been \$5.80 - \$7.80 per kg based on charge weights.
