## Baggage Restrictions and Prohibited Items , Turkish Airlines

Spare lithium metal/lithium ion battery or batteries: These batteries, for portable electronic devices, must be carried as hand/cabin baggage. The amount of lithium in lithium metal batteries must be equal to or less than 2 grams and the power of lithium ion batteries must be equal to or less than 100 Watt/hour.
