

Mailing lithium batteries internationally





Overview

The short answer is yes, you can ship lithium batteries overseas. Lithium batteries are classed as 'Dangerous Goods', which means there are certain limitations on how they can be shipped. A charged lithium battery can, under very particular circumstances, catch fire. Can You ship lithium ion batteries overseas?

Unlike when shipping smaller lithium-ion batteries, new electric vehicles are moved overseas in huge Ro-Ro vessels, with their batteries secured and not live during the shipping process. Best Practices: Shipping Lithium Batteries in Container Ship.

Can I ship a lithium battery cross-border?

There are regulations attached to the cross-border shipping of batteries to ensure they travel safely. These regulations vary depending on the type of batteries. Lithium batteries, for example, are classified as Dangerous Goods, so not all types of lithium batteries are accepted by DHL Express which you can check here.

How do you ship lithium ion batteries?

Goods must be labelled as "Lithium Ion Battery" or "Lithium Metal Battery" and include appropriate shipping marks and hazard labels. Lithium batteries must have the correct documentation - including a Dangerous goods declaration, air waybill, and packing list. Can you Ship Lithium-ion Batteries Internationally?

Can I send lithium batteries in airmail?

No, you cannot send lithium batteries, by themselves, in the airmail. You will need to contact your local postal authority to see if you be able to ship them by surface methods i.e. sea, road and rail. If you have to send the lithium batteries by air, then you will need to send them with a freight company.



Can You ship a battery across a country?

Many electronic products and devices contain batteries – in particular, lithium batteries, which are commonly found in laptops, smartphones, tablets, medical devices and power tools. There are regulations attached to the cross-border shipping of batteries to ensure they travel safely. These regulations vary depending on the type of batteries.

Is lithium battery shipping dangerous?

While classified as a dangerous good, lithium battery shipping takes very specific requirements. that you can find inside the Dangerous Goods Regulations. However, if you only ship lithium batteries you can purchase the Lithium Batteries Shipping Regulations as a standalone manual.

Lithium Battery International Shipping: Requirement and Guide

1. Any lithium battery must pass the UN38.3 test before shipping internationally. If the lithium battery does not contain in the device, and each package involves more than 24 battery cells or 12 batteries, it must also fit a 1.2-meter crash test from any direction. 2.

Only lithium batteries under 622.51 and 622.52 that are properly installed in the equipment they operate may be sent internationally or to, from, or between APO, FPO, or DPO locations (subject to the conditions prescribed by the U.S. Department of Defense).



Easy Ways to Send Lithium Batteries Overseas: 14 Steps

Use a Lithium Battery Mark on batteries with less than 100 Wh or 2 g of lithium. Look online for a Lithium Battery Mark editor so you can add the information for your shipment. When you ship lithium ion batteries, use "UN3480" for single battery shipments and "UN3481" if they're packaged with equipment.

The prohibition on mailing lithium batteries and cells internationally also applies to mail sent by commercial air transportation to and from an APO, FPO, or DPO location. In addition, we will revise and renumber Exhibit 601.10.20.7 to reflect "watt-hour ratings" instead of "lithium content" for secondary lithium-ion batteries when describing maximum quantity limits.

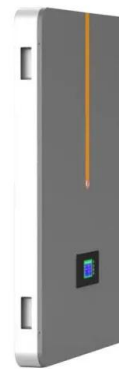
ABCs of mailing

You may only mail lithium batteries: Meeting the conditions outlined in Schedule 2, Special Provision 34 of the Transportation of Dangerous Goods Regulations. Subject to the restrictions set out in the table below Please note: You aren't allowed to ship lithium
