Who is Mitsubishi Hitachi Power Systems?

2014 Mitsubishi Hitachi Power Systems, Ltd., a joint venture company formed by Mitsubishi Heavy Industries and Hitachi integrating thermal power generation systems and other related businesses, established. Mitsubishi Hitachi Power Systems' Takasago Works was formed as a result.

Why did Hitachi withdraw from Mitsubishi Hitachi Power Systems?

Japanese technology conglomerate Hitachi will withdraw from Mitsubishi Hitachi Power Systems (MHPS), a joint venture it established in 2014 with another power equipment giant, Mitsubishi Heavy Industries (MHI), over a dispute stemming from construction of two massive defect-ridden coal plants in South Africa.

Why did Hitachi change its name?

The company has been planning to change its name following the transfer of all stock held by Hitachi, Ltd. to Mitsubishi Heavy Industries, Ltd. Mitsubishi Power will begin operating under the new name once it receives approvals from antitrust authorities in several countries, and necessary procedures for the stock transfer have been completed.

When did Mitsubishi Heavy Industries merge with Hitachi?

(Hitachi Canada) Mitsubishi Heavy Industries merged with Hitachi Ltd. in February, 2014. "They are closing the doors on my shop. I am employed until October 15, after that they are putting the chains on the gates," wrote one worker.

Is Mitsubishi Power a comprehensive energy company?

With these changes, MHI's structure will be strengthened as a comprehensive energy company. Mitsubishi Power is a wholly owned MHI subsidiary originally established in February 2014 as Mitsubishi Hitachi Power Systems, Ltd., a
