The European Commission on Monday approved a new aid scheme for the deployment of large-scale electricity storage in Spain. Subsidies will be available for standalone energy storage sites, projects installed alongside renewable energy facilities, and storage planned as part of thermal power plants.

Will Spain start a new energy storage scheme?

The Ministry of the Environment of Spain has launched its latest financial support scheme for energy storage, aiming to kickstart 2.5-3.5GW.

How much money will Spain spend on energy projects?

Nearly half of the financial support will be allocated to the southern region of Andalusia, with €311 million, followed by the northwestern region of Galicia with €86 million and the central region of Castilla-La Mancha with €80 million. The projects will make the energy system in Spain more flexible, robust, and resilient, MITECO said.

Does Spain support energy storage?

Spain already backs energy storage with more than €600 million of NextGenEU funding which was allocated as part of Spain's, post-Covid Recovery, Transformation, and Resilience Plan. From pv magazine España.



Can energy storage projects get 85% co-financing?

Standalone and renewables-plus-storage battery projects can apply for up to 85% co-financing, along with pumped hydro and thermal energy storage sites. Friday saw the publication of a call for applications for energy storage projects hoping to receive support from a €700 million (\$794 million) EU-funded program in Spain.

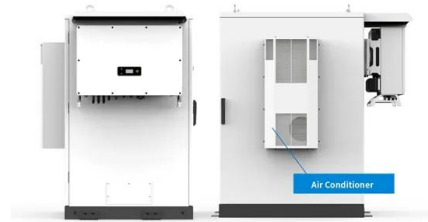

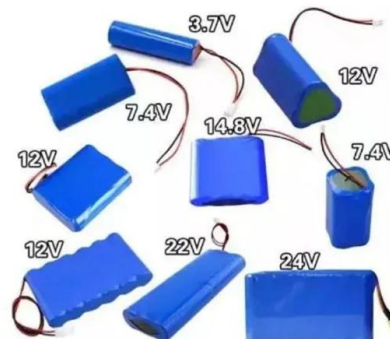

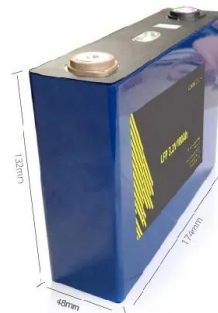
