What are the government's proposed reforms to the capacity market?

This week we look at the government's proposed reforms to the Capacity Market, the new Energy Bills Discount Scheme, the government's responses to a consultation on a market-based mechanism for low-carbon heat and NG ESO's yearly review. The government published its proposed reforms to the Capacity Market (CM) on 9 January 2023.

What will the government say about energy reform in 2035?

The government continues to seek views on a wide range of energy reform options, with an update on REMA expected early this year. RenewableUK's Chief Executive Dan McGrail said: It's vital that we decarbonise our electricity system completely by 2035, so this consultation represents an important step forward in that process.

What is the long duration energy storage Investment Support Scheme?

Long Duration Electricity Storage investment support scheme will boost investor confidence and unlock billions in funding for vital projects. The UK is a step closer to energy independence as the government launches a new scheme to help build energy storage infrastructure.

Will the UK government introduce reform to electricity markets?

The UK government will introduce reform where this proves necessary. REMA will consider a range of options for reform to electricity markets and policies that can provide signals for the investment in, and operation of, assets that generate or use electricity.

What is REMA & how will it impact GB electricity markets?

With electricity demand set to at least double over the next 13 years, REMA will focus on establishing a fit-for-purpose market design, identifying and implementing the reforms needed to GB electricity markets that work for



businesses, industry, and households.

When will the energy bills discount scheme reopen in 2023?

The consultation on the proposed reforms opened on 9 January 2023 and will close on 3 March 2023. The government aims to publish a response in spring 2023. The government has announced a new Energy Bills Discount Scheme for UK businesses, charities and the public sector.

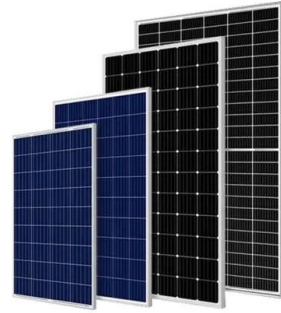

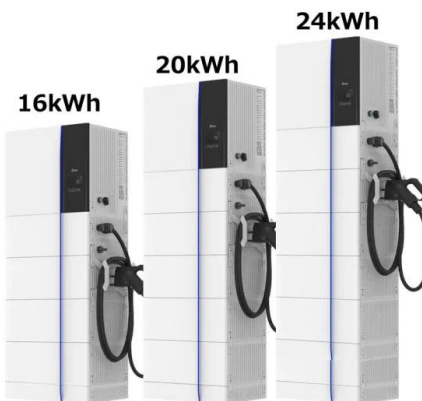
