

Notice of Removal of Illegal Photovoltaic Panels





Overview

When should solar PV equipment be removed from a building?

(a) the solar PV equipment or solar thermal equipment must, so far as practicable, be sited so as to minimise its effect on the external appearance of the building and the amenity of the area; and (b) the solar PV equipment or solar thermal equipment is removed as soon as reasonably practicable when no longer needed.

Is it illegal to dispose of solar panels in landfills?

This makes it effectively illegal to dispose of solar panels in landfills. Solar panels contain environmentally toxic metals such as lead, selenium or the carcinogenic cadmium. If they are not carefully disposed of, they can create environmental hazards.

Can I install solar panels if I don't meet building regulations?

Your local authority can also apply for a Confiscation Order to take away any money you've earned with your system – so there's absolutely no benefit to installing solar panels that don't meet building regulations. It's crucial that your solar installation follows all building regulations.

Are solar panels e-waste?

PV panels are defined as e-waste in the Waste Electrical and Electronic Equipment (WEEE) Directive. Although this is an EU directive, the UK currently adheres to it. This makes it effectively illegal to dispose of solar panels in landfills. Solar panels contain environmentally toxic metals such as lead, selenium or the carcinogenic cadmium.

When did solar panels become a building regulation?

In 2005, household electrical work was absorbed into the UK government's official Building Regulations. A year later, the Climate Change and Sustainable Energy Act 2006 brought microgeneration systems like solar panels under the

Can solar panels be built without permission?

This is because they generally fall under permitted development rights, which allow homeowners to make reasonably sized changes without getting permission. The exceptions to this rule are typically flats, listed buildings, homes in conservation areas, and ground-mounted installations. What are the building regulations for solar panels?

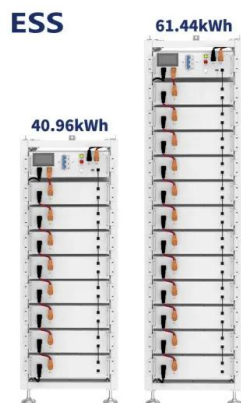

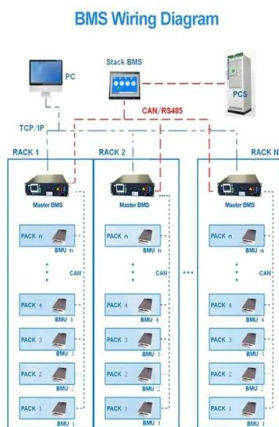
