Should I 'safe harbor' my solar projects now?

With new guidance from the IRS, it's time to 'safe harbor' your solar projects. Last year, the United States Internal Revenue Service (IRS) issued clarification on the future of the Investment Tax Credit (ITC) for US solar projects.

Is it beneficial to safe harbor solar projects?

Safe harboring for solar projects is a popular choice due to the generally understood and relatively simple requirements, based on ICF's experience with wind. So, what do you need to know about this option for solar projects?

Are solar PV installations notifiable?

To clarify, what is certain is that nearly all domestic electrical work is notifiable under Part P of the Building Regulations (see below) and a solar PV installation is nearly always notifiable electrical work.

Are solar PV installations secure?

Whilst there is an acknowledged need to ensure solar PV installations are adequately secured it would be unfortunate if such security measures resulted in an unacceptable landscape/visual impact. Applicants should: minimise the use of security lighting. Any lighting should utilise.

Are large scale solar PV arrays listed in the EIA Regulations 1999?

Large scale solar PV arrays are not expressly listed in Schedule 2 to the EIA Regulations 1999; such developments may or may not have a significant effect on the environment, positive or negative, depending on location. As a starting point the proposal should be assessed against the selection criteria in Schedule 3 of the EIA Regulations.



What is a stand-alone solar PV installation?

For the purposes of planning stand-alone solar PV installations are those that are not physically attached to a building, although they can be wired to provide electricity to a building.
