Can a provider sell a photovoltaic system to a customer?

WHEREAS, Provider has offered, at his sole cost and expense, to install, maintain, own, replace, repair, and operate a photovoltaic system at one or more of the Property (ies) and to sell Solar Services (as hereafter defined) produced by the solar photovoltaic system to Customer as provided in and subject to the provisions of this Agreement.

What is a power purchase agreement (PPA)?

A Power Purchase Agreement (PPA) refers to a contractual agreement between two parties, typically a power producer and a customer. The producer usually arranges the design, gains the necessary permissions and manages the installation of a solar PV system on the customer's property at little to no cost.

What is a solar PV PPA & how does it work?

A PPA offers an effective means to reaping the benefits of solar PV without having to take on the responsibilities of being a solar system owner-operator.



A PPA also satisfies companies that prefer to reinvest their funds into core businesses activities.

How long is a solar PPA contract?

The term of a solar PPA is typically 25 years. The developer is responsible for the operation and maintenance of the system for the duration of the agreement. At the end of the PPA contract term, a customer may be able to extend the PPA, have the developer remove the system or choose to buy the system from the developer.
