Overview

What is the solar photovoltaic industry alliance?

Today, the Commission is formally endorsing a new Solar Photovoltaic Industry Alliance, with the aim of scaling up manufacturing technologies of innovative solar photovoltaic products and components. This will contribute to accelerating the deployment of solar power across the EU and improving the resilience of the EU's energy system.

How does the EU support the European solar PV manufacturing sector?

Over the last years, the EU has taken initiatives to strengthen its support to the European solar PV manufacturing sector, which includes several globally competitive companies in several steps of the value chain.

When will the European Solar charter be implemented?

One year following the signature of the Charter, the Commission will review the implementation of the adopted commitments. The European Solar Charter, signed on 15 April 2024, sets out a series of voluntary actions to be undertaken to support the EU photovoltaic sector.

What is the European solar PV industry alliance (ESIA)?

The European Solar PV Industry Alliance (ESIA), launched in December 2022 to reinforce the cooperation within industry, set itself the target of 30 GW of production capacity along the value chain, an objective considered achievable by 2030. The ESIA pipeline includes more than 20 projects, including several at multi-GW scale.

Why is the solar photovoltaic industry important?

Speaking after the signature ceremony, Commissioner Kadri Simson said 'The solar photovoltaic manufacturing sector is key for achieving our energy, climate and competitiveness goals. We must ensure the solar industry remains strong for Europe's future, renewables-centred energy mix.'

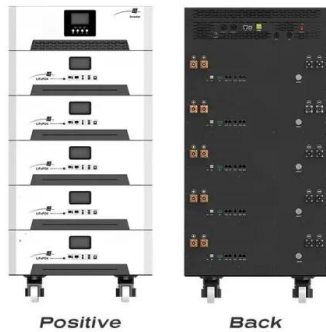


What is the EU photovoltaic charter?

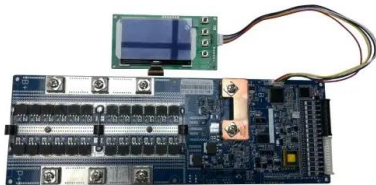
