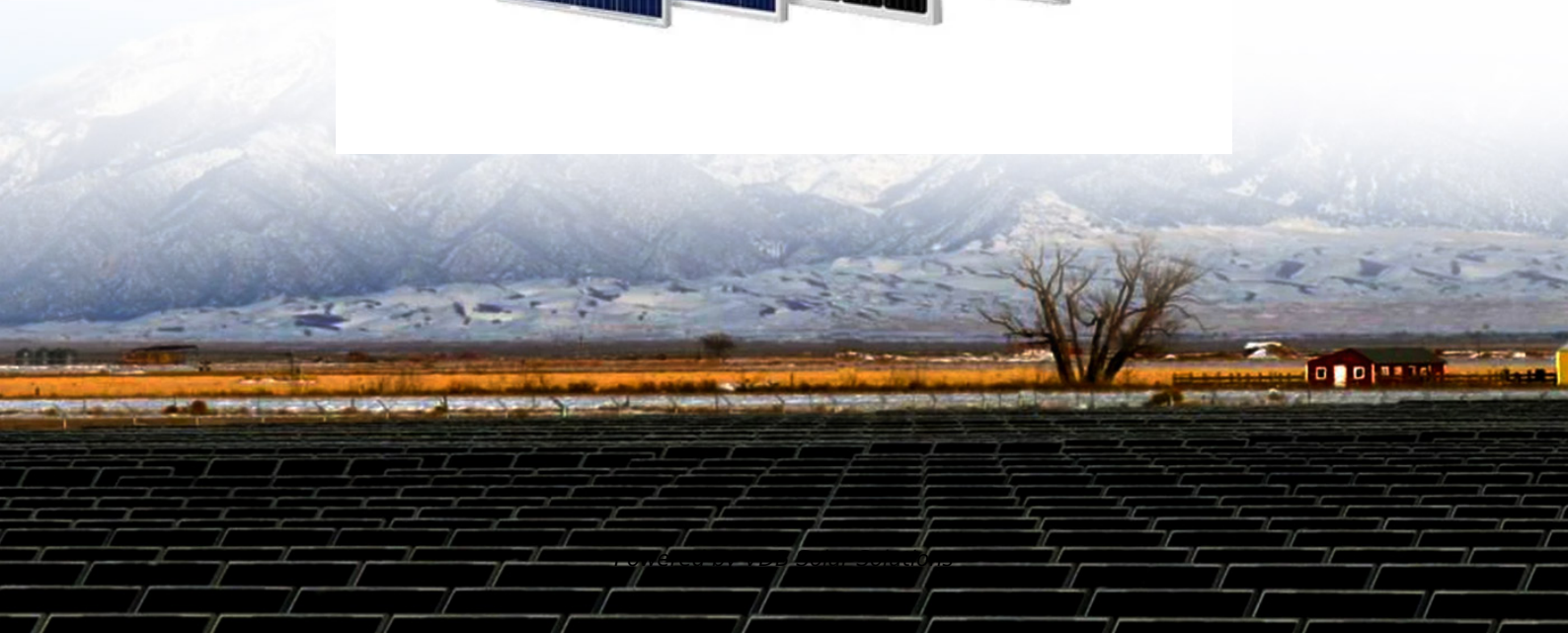

Overview

Why is quality of Environmental Impact Assessment Reports important?

The quality of Environmental Impact Assessment Reports (EIARs) plays a critical role in a well-functioning Environmental Impact Assessment (EIA) system as EIARs are the key tool used by decision makers. Several studies have been conducted locally and abroad regarding the quality of EIARs across various sectors.

What is Environmental Impact Assessment (EIA)?

It is part of a guidance package designed to help in the identification of key impacts of specific projects as part of the scoping process in Environmental Impact Assessment (EIA). It should be used in conjunction with the associated guidance notes that describe the impacts of many different types of individual development projects.

Does EIAR quality improve in solar PV projects in South Africa?

The study considered the improvement of quality of EIARs compiled for solar PV projects in South Africa between 2011 and 2017. In order to establish the necessary understanding of EIAR quality, a literature review was conducted, investigating both international and local case studies of a similar nature.

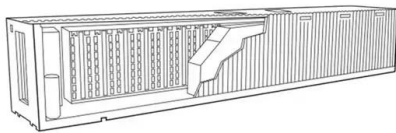
