However, the biggest obstacle facing new solar projects was a lack of capacity in the electricity grid, Solar UK said.

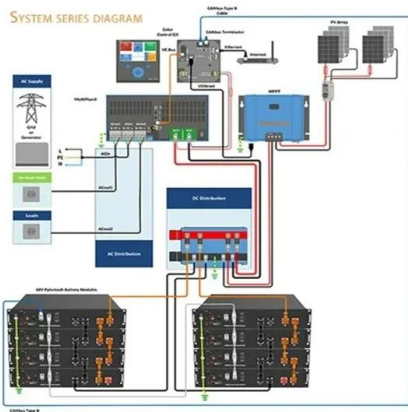
