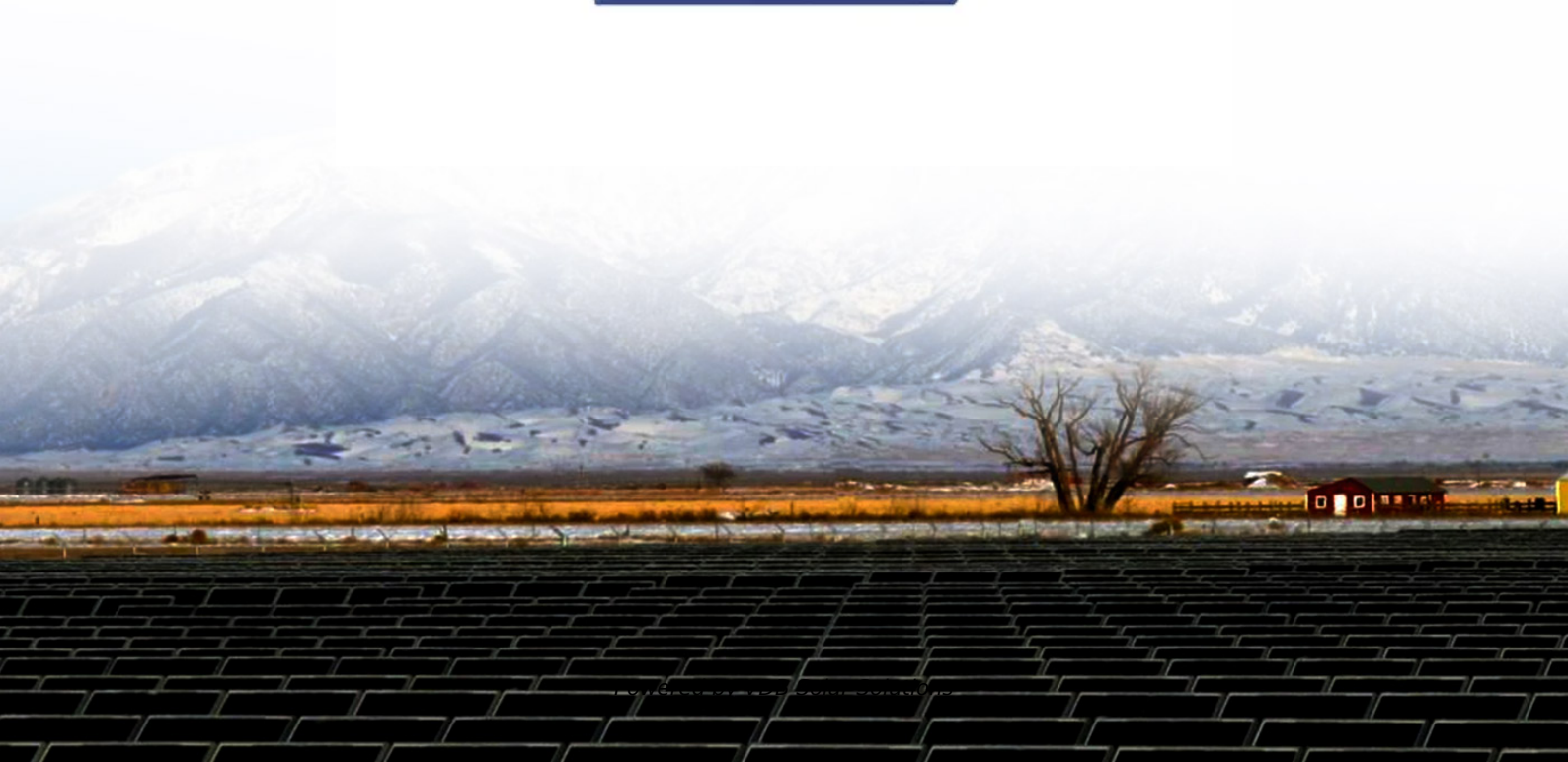

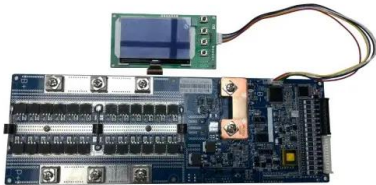

After closing the San Juan coal-fired power plant in 2022 and exiting Four Corners in 2024, more than two-thirds of PNM's energy will come from renewable energy, according to the 2020 IRP.



PNM's 2025 renewable energy plan proposes cheaper renewable ...



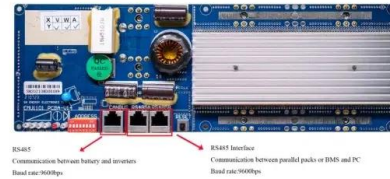

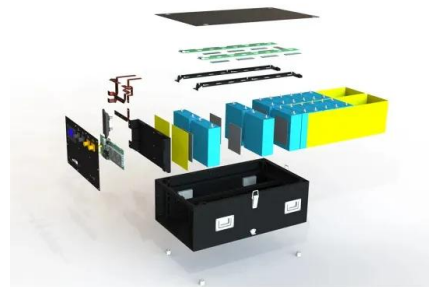
