

# **Power company miscalculates my solar credits**





## Overview

What is a solar tax credit?

The solar tax credit is a dollar-for-dollar reduction in your tax liability worth up to 30% of the cost of a solar and/or battery project. This incentive is also known as the investment tax credit (ITC) and Residential Clean Energy Credit.

How do Solar credits work?

How do my solar credits work?

Your total production is the amount of energy your solar panels generate, which is then used by your home. Any excess energy that you do not use is sent to the grid, and we credit you for that excess production.

How do solar PV tax credits work?

For example, if your solar PV system was installed in 2022, installation costs totaled \$18,000, and your state government gave you a one-time rebate of \$1,000 for installing the system, your federal tax credit would be calculated as follows: State tax credits for installing solar PV generally do not reduce federal tax credits—and vice versa.

Can I get a tax credit if I install solar energy?

If you install solar energy equipment in your residence any time this year through the end of 2032, you are entitled to a nonrefundable credit off your federal income taxes equal to 30 percent of eligible expenses.

How many times can you claim a solar tax credit?

Homeowners can claim the solar tax credit once per solar and/or battery system installed on an eligible property, and the credit must be claimed in the tax year the system was deemed operational. There are a few scenarios where the same person could claim the solar tax credit more than once.



How do I claim a tax credit for solar panels?

To claim your tax credit for solar panels, you must file Form 5695, Residential Energy Credits, along with Form 1040, for the year the panels were installed. You'll need the following information to file your form: Qualified expenses include labor costs for preparation, assembly and wiring, the price of the panels, taxes and other specified costs.
