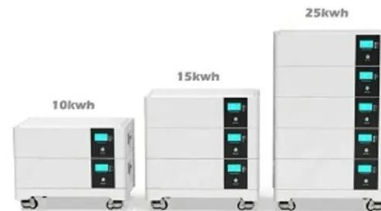

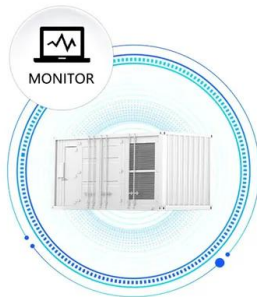


## Renewable Energy Directive 2018
