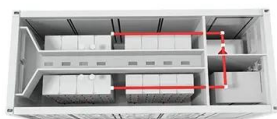

One available incentive program is the Community Renewables Program at the Renewable Energy Fund at Commerce Rhode Island. This first come, first serve program is available to community solar developers who will pass on the grants to subscribers in the form of a bill credit on their community solar bill.

The RE Growth Program is administered by National Grid for four types of renewable energy: wind, solar, hydro, and anaerobic digestion. The program lets customers earn a constant payback rate on energy that they produce. Additionally, it runs from April 1 st to March 31 st and is updated every year. and is updated every year.

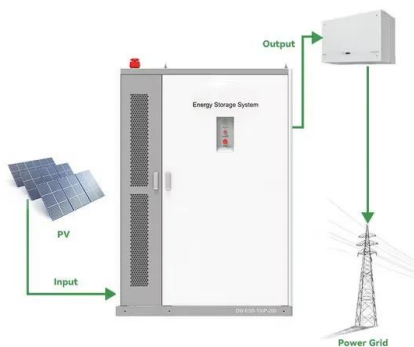
