

# **Shipping lithium ion batteries from us to canada**





## Overview

---

Yes. In Canada, the shipping and importing of lithium batteries is subject to the Transportation of Dangerous Goods Act, 1992 (TDG Act) and its regulations. They are considered dangerous goods much like gasoline, propane and sulfuric acid. Can I ship a lithium battery cross-border?

There are regulations attached to the cross-border shipping of batteries to ensure they travel safely. These regulations vary depending on the type of batteries. Lithium batteries, for example, are classified as Dangerous Goods, so not all types of lithium batteries are accepted by DHL Express which you can check here.

Can You ship lithium batteries by air?

When you ship lithium batteries, either alone, contained in or packaged with devices and equipment, you must meet shipping requirements for dangerous goods. Different rules apply depending on whether you are shipping by ground or by air. Shipping lithium batteries by Ground.

Can You ship a battery across a country?

Many electronic products and devices contain batteries – in particular, lithium batteries, which are commonly found in laptops, smartphones, tablets, medical devices and power tools. There are regulations attached to the cross-border shipping of batteries to ensure they travel safely. These regulations vary depending on the type of batteries.

Are lithium batteries safe to ship in Canada?

All designs and types of lithium batteries must meet the requirements of the UN Manual of Tests and Criteria to be shipped safely. Shippers and importers must meet the requirements set out in the TDG Regulations for the handling, offering for transport, transporting and importing of lithium batteries in Canada.

How do I import lithium batteries into Canada?



The TDG Regulations specify requirements for classification, documentation, labelling, packaging and training. You must declare them to postal carriers, couriers or transport companies. Make sure that the lithium batteries in your shipment are not counterfeit before importing them into Canada.

How do you ship a lithium battery?

Shipping lithium batteries by Ground Regardless of shipping method, it is important to package lithium batteries carefully: Separate each battery from any metal object in the package to prevent short circuits. Insulate battery terminals with a non-conductive material such as electrical tape or by placing each battery in a plastic bag.

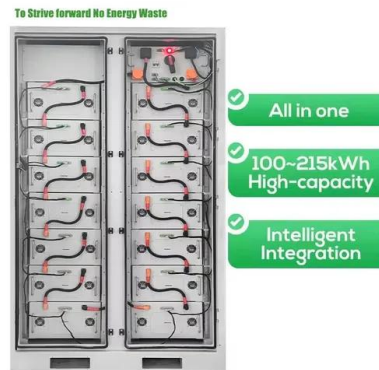

For shipping, all types of lithium batteries are classified as dangerous goods -- with special regulations for packing, labelling, documentation and handling. FedEx adheres to IATA regulations for shipping lithium batteries by air and ADR regulations for shipping lithium batteries by road in Europe.



## Lithium Batteries

In Canada, the shipping and importing of lithium batteries are subject to the Transportation of Dangerous Goods Act, 1992 and its Regulations. There are two main kinds of lithium batteries: A lithium metal battery is usually non-rechargeable, contains metallic lithium, and features a higher energy density than other non-rechargeable batteries.

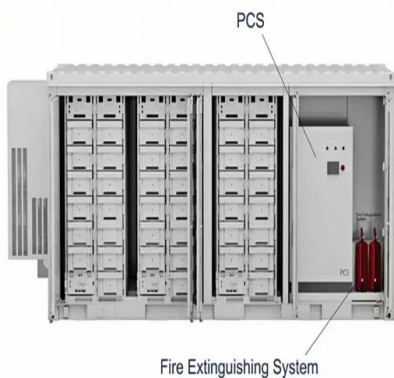
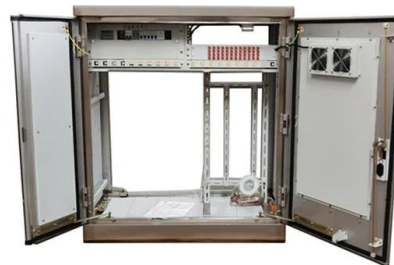

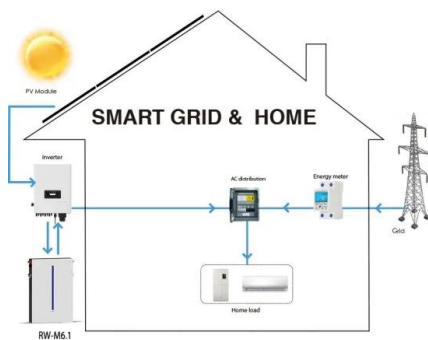

Yes. Batteries packed with or in equipment (UN 3091 and 3481) may still be shipped compliantly, subject to regulations. (Passengers may still transport their battery powered devices and spare batteries in their carry-on bags--for now. ...
