What are the credit terms for solar glass sales?

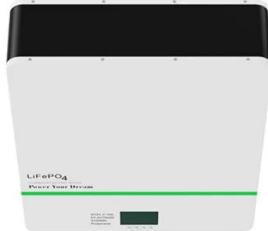
