Will a solar power plant be built in Mineral County?

CHARLESTON, W.Va. (WBOY) — A leading solar energy company has been approved to built a 100-megawatt solar power plant in Mineral County. The Public Service Commission of West Virginia (PSC) announced in a press release Wednesday that it has approved the plant and a battery storage facility along with it.

What is Mineral Basin solar?

Mineral Basin Solar is a 402 MWac solar project with the potential to power 75,000 households annually. The Mineral Basin Solar Project is sited on reclaimed mine land and will be the largest solar project in Pennsylvania.

Is off-site battery energy storage a potential option for the Mineral Basin solar project?

SCE is considering off-site battery energy storage as a potential option for the Mineral Basin Solar Project. The potential storage component will use lithium-ion battery cells, which is the same type of battery found in everyday consumer electronics and medical devices.
