

# Solar panel eligibility





## Overview

---

According to Ofgem, you might be eligible to get solar panels with the ECO4 scheme if: Your home has a low EPC rating (usually this means a 'D' rating or below). AND your home has an existing electric heating system You are living at private domestic premises. If you do not own your own home, you must have the permission of your landlord, including if your property is owned by a social housing provider or management company Who is eligible for a solar PV tax credit?

A tenant-stockholder at a cooperative housing corporation and members of condominiums are still eligible for the tax credit if they contribute to the costs of an eligible solar PV system. In this case, the amount you spend contributing to the cost of the solar PV system would be the amount you would use to calculate your tax credit.

How much can I claim if I have a solar PV system?

- There is no maximum amount that can be claimed.
- Your solar PV system was installed between January 1, 2006, and December 31, 2023.
- You own the solar PV system (i.e., you purchased it with cash or through financing but you are neither leasing nor are in an arrangement to purchase electricity generated by a system you do not own).

Can I claim a credit for a solar PV system?

- You own the solar PV system (i.e., you purchased it with cash or through financing but you are neither leasing nor are in an arrangement to purchase electricity generated by a system you do not own).
- The solar PV system is new or being used for the first time. The credit can only be claimed on the "original installation" of the solar equipment.
