

# **Solar power generation land lease contract**





## Overview

A solar land lease is an agreement between a landowner and a developer<sup>12</sup>. The landowner rents land to the developer for the purpose of housing photovoltaic solar arrays and generating solar energy. These leases are typically long-term agreements, lasting 20-50 years<sup>3</sup>.

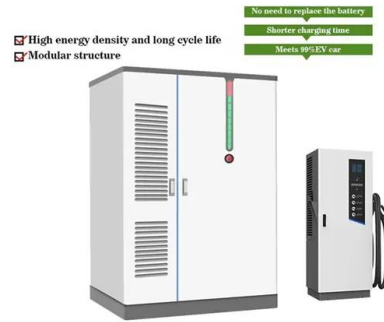
