## Overview

What is WeChat Pay?

Since its official launch in August 2013, WeChat Pay has been committed to providing users and enterprises with safe, convenient and professional online payment services<sup>1</sup>. With the core concept of "WeChat Pay, more than payment", it has created a variety of convenient services and application scenarios for individual users.

Are there transaction fees on WeChat?

A: Yes, there are transaction fees. However, transaction fees are waived for single transactions under 200 RMB. A 3% transaction fee will be applied for single transactions above 200 RMB. If you request a refund for a transaction, the transaction fee will be reimbursed in proportion to the refunded amount.

Are AliPay & WeChat Pay a problem in China?

The comprehensive ecosystems of Alipay and WeChat Pay have made payments in China among the most convenient and frictionless in the world with one important caveat: One must be within the domestic Chinese payments ecosystems, with a Chinese bank account that can be tied to the payment apps. This has not been a bug of the system, but a feature.

Who is eligible for WeChat overseas remittance?

Only Chinese users -- including those from Hong Kong, Macau, and Taiwan -- who have successfully completed real-name authentication are eligible for the WeChat Pay and Alipay international transfer feature<sup>19</sup>. WeChat Overseas Remittance is only available to users who have linked a bank card in Mainland China to their WeChat Pay account.

How much money can I withdraw from a wechat account?



a. Verified Account: The aggregate of the top-up amount and the Wallet Balance must not exceed RM4,999. b. Unverified Account: The aggregate of the top-up amount and the Wallet Balance must not exceed RM1,500. 3. Balance Withdrawal: a. Each WeChat Pay MY account has a daily withdrawal limit of RM4,500, and a monthly withdrawal limit of RM10,000. b.

Does WeChat Pay support foreign bank accounts?

It is good to know that both WeChat Pay<sup>17</sup> and Alipay<sup>18</sup> now support foreign bank accounts, including VISA, JCB and MasterCard. You can choose to add a foreign bank account, and top up WeChat Pay Wallet and Alipay account balance directly.

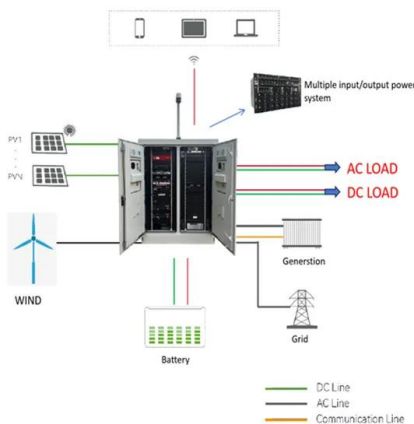
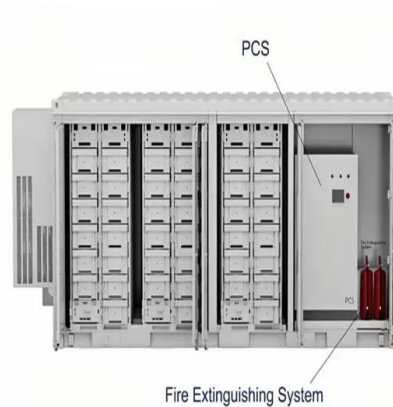

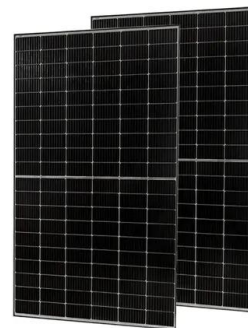
