Is EQT AB acquiring UK battery storage firm statera Energy Ltd?

Private equity firm EQT AB has agreed to acquire UK battery storage firm Statera Energy Ltd. as it boosts its bets on the energy transition. EQT is acquiring the business from InfraRed Capital Partners through its EQT Infrastructure VI fund, according to a statement Monday, which confirmed an earlier Bloomberg News report.

How much power does statera have?

Statera has 1GW of flexible generation in operation and under construction, enough to power around 750,000 homes, and a total project pipeline of over 16GW, with plans to deliver 7.5GW of flexibility assets by 2030.

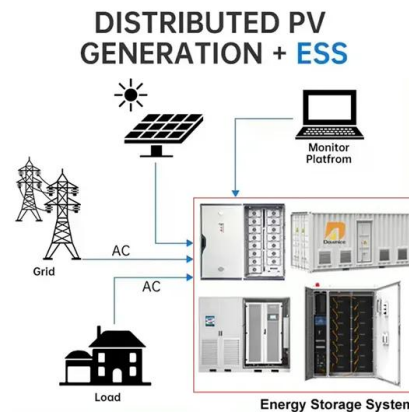
