

# **Tax rebates for solar panels**





## Overview

What is a solar panel tax credit?

The solar panel tax credit allows filers to take a tax credit equal to up to 30% of eligible costs. There is no income limit to qualify, and you can claim the credit each year you're eligible for it. The credit amount will remain 30% through 2032.

Is the federal solar tax credit refundable?

In 2020 - 2021, the ITC was reduced to 26%. The Inflation Reduction Act of 2022 reinstated and renamed the program the Federal Solar Tax Credit (now known as the Clean Residential Energy Credit) and raised the credit back up to 30%. The Residential Clean Energy Credit is non-refundable.

Are solar PV systems eligible for a tax credit?

Solar PV systems installed in 2020 and 2021 are eligible for a 26% tax credit. In August 2022, Congress passed an extension of the ITC, raising it to 30% for the installation of which was between 2022-2032. (Systems installed on or before December 31, 2019 were also eligible for a 30% tax credit.)

What is the 30% residential solar tax credit?

Now that you have your very own solar system, the 30% Residential Solar Tax Credit is yours for the claiming. How exactly do you go about it?

In this post, we'll walk you through the basics of how to file for the federal solar tax credit.

Does a solar battery qualify for the solar tax credit?

Even for grid-tied solar power systems, having a solar battery provides additional energy security during a blackout. For your solar battery to qualify for the Residential Clean Energy Credit, it must have a minimum storage capacity of 3kWh. Here are two examples of off-grid residential solar power



systems eligible for the 30% solar tax credit.

How much is a solar tax credit worth?

Even though it's commonly known as the solar tax credit, the Residential Clean Energy Credit also applies to battery storage, wind, geothermal heat pump, and fuel cell expenditures. So if your all-in solar cost is \$25,000, your federal solar tax credit would be worth \$7,500.

### Federal Solar Tax Credit: Take 30% Off Your Solar Cost

Since the federal solar tax credit is applied to your solar array's gross system cost, the amount you receive is dependent on the amount of solar you're purchasing: bigger system, bigger credit. Here's a quick example of the difference in credits in 2021 and 2022 for a 9 kW solar array at an average cost of \$27,000.

For tax years 2022 to 2032, you can get a credit for up to 30% of the expense of installing solar panels; this may include the price of the panels themselves, sales taxes and labor costs.

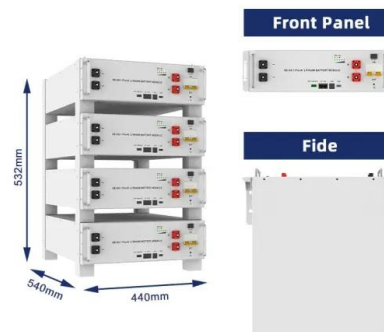
