

# **WeChat can pay the radio and television network fees**

### What is WeChat Pay?

WeChat Pay is a payment feature integrated into the WeChat app, allowing users to complete payments quickly and securely on their mobile phones. Users can link their bank cards, receive and transfer money, pay bills, and make purchases both in-store and online. Download WeChat from the App Store or Google Play.

### Can I use WeChat Pay abroad?

The good news is that starting July 20, 2023, WeChat Pay has fully upgraded its services for international bank card users. From July 20, 2023 onwards, overseas users can use WeChat Pay bound to their foreign payment cards for the vast majority of merchants in dining, transportation, hospitality, supermarkets and other sectors across China.

### Does WeChat Pay charge a transaction fee?

In terms of fees, WeChat Pay charges a 3% transaction fee for purchases above RMB 200 (~S\$37). However, for smaller purchases below RMB 200, there are no transaction fees. Q: Does WeChat Pay have any spending limitations?

### Will WeChat Pay & Alipay work in China?

Starting from the end of July 2023, overseas users or tourists who link their international cards to WeChat Pay and Alipay will be able to use mobile payments at the vast majority of merchants in China. This includes various sectors such as shopping, dining, transportation, as well as accommodation payment.

### Do all stores accept WeChat Pay?



Not all stores accept WeChat Pay. Do keep an eye out for any in-store WeChat Pay signage or enquire with the staff directly before making a payment! You can also use Alipay as an alternative payment method – here's our Alipay for foreigners guide!.

Can I use WeChat Pay in China as a foreigner?

If you suspect any unauthorized transactions, report them immediately to WeChat support and your bank. Using WeChat Pay in China as a foreigner might initially seem complicated, but once set up, it offers a convenient and integrated payment solution that enhances the travel or living experience in China.

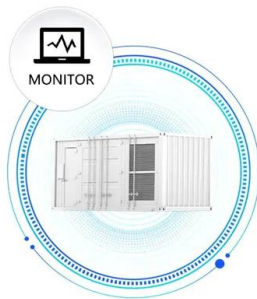

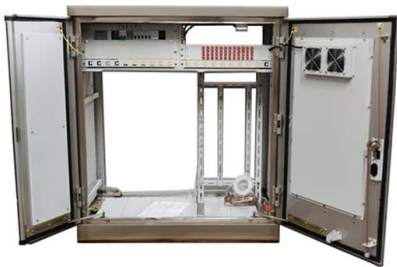
