Do inverters & batteries qualify for a solar incentive?

The incentive excludes inverters and batteries because, although they are required to use solar panels, inverters and batteries can be operated without solar panels – in which case they offer no additional capacity to the system, Treasury said.

Will tax incentive for solar PV be extended to batteries & inverters?

Electricity Minister Kgosientsho Ramokgopa says his department is "advocating" for the tax incentive for solar PV to be extended to batteries and inverters. Solar rooftop installations more than doubled since July 2022.

What is the solar PV incentive?

The calculation of the incentive is proposed to be 25% of the cost of solar PV panels with an upper limit of R15 000. The incentive will limit the credit to solar panels that meet all the following requirements:.

What are the requirements for a solar PV credit?

The incentive will limit the credit to solar panels that meet all the following requirements: New and unused solar PV panels acquired by the individual and brought into use for the first time by the individual on or after 1 March 2023 and before 1 March 2024. The minimum generation capacity of each panel must not be less than 275W.

What is the tax incentive for solar panels?

Government is offering a 25% tax incentive to households on their solar PV panels. The incentive has been effective since 1 March 2023 and will run until 29 February 2024. Claims are capped at R15 000. The incentive strictly applies to solar panels - and not to inverters or batteries.

How do I claim a solar PV rebate?



Individuals will be able to claim the rebate if they have: A VAT invoice that indicates the cost of the solar PV panels separately from other items, along with proof of payment. A CoC evidencing that the solar PV panels were brought into use for the first time between 1 March 2023 and 29 February 2024.

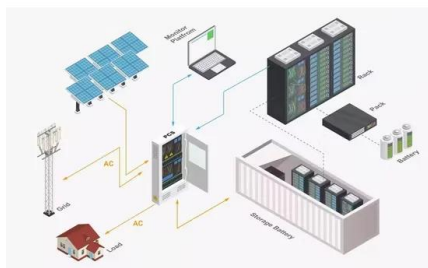
